Change cartridges when capacity is reached or when pressure decreases

INSTALLATION TIPS

Mounts directly onto flat surface.

Install vertically so cartridge hangs down.

Allow 2½" clearance below the cartridge for easy cartridge replacement.

Flush filter by running water through filter according to cartridge instructions.

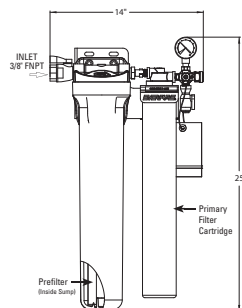
