## Snapshot

The OptiPure QT2+MP Multi-Point Filtration System provides a combination of filters to meet the requirements of different equipment applications including fountain beverages, ice and coffee. The system includes four Qwik-Twist cartridges. The first cartridge is a 5-micron QT sediment pre-filter, followed by two primary cartridges that reduce sediment down to 0.5-microns and reduces chlorine, taste & odor at a flow rate a 4.5 gpm for 45,000-gallons. The fourth cartridge is a secondary filter that provides added scale protection with IsoNet® for ice machines and coffee brewers.

## System Benefits

- Reduces maintenance frequency and cost, and extends equipment life.
- Dual system outlets provide primary filtration for cold beverages and additional secondary filtration for ice machines and coffee brewers.
- Primary filtration protects against dirt, rust and other debris, makes water taste great and protects equipment against corrosive chlorine.
- Secondary filter provides the added protection of IsoNet®, OptiPure's patented scale inhibiting technology, which helps protect equipment against scale and corrosion for the rated capacity of the system.
- Additional 5-micron pre-filter provides further protection on water supplies with excessive sediment.
- New manifold design provides fewer possible leak points.
- Compact design, heavy duty mounting bracket and multi-function valve simplify installation.
- Multi-function control valve provides:
  - \* Shutoff valve for quick and simple filter replacements
  - \* System bypass valve for easy system maintenance
  - \* Flush port to flush cartridges after installation
- Built-in pressure gauge allows visual monitoring of when filters need to be changed.
- Utilizes Qwik-Twist cartridges that make changing filters quick, easy and sanitary.
- NSF certified under standard 42.

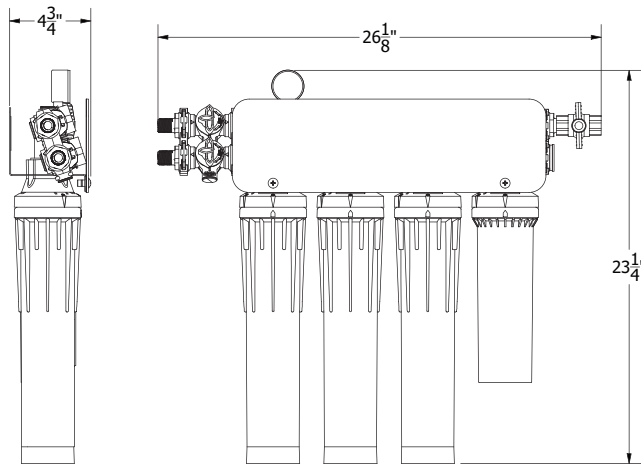
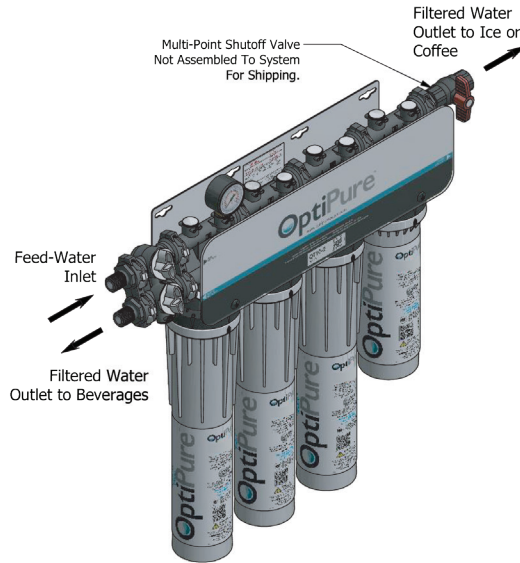

- No activation procedure or flushing required for system to perform as specified.

It is recommended that pre/post-filters and mineral addition cartridges are changed every 6 months, when capacity is reached or when feedwater pressure or flow becomes inadequate.

Membrane life varies depending on feedwater conditions and pre-filter maintenance. It is 12-18 months under typical conditions, but it can be as long as 3-5 years.

This product is for commercial use only and must be installed and maintained according to manufacturer's guidelines.

Do not use on water that is microbiologically unsafe or of unknown quality without adequate disinfection before or after the system.
